1. Rate is based on Schedule of rates of Building Construction Department, Government of Bihar, effective from 01.01.2022 for civil work & 2018 for Electrical works.
2. Earnest Money is to be deposited in the shape of N.S.C., Post office time deposit, duly pledged to the Principal, B.N. College, Patna & D.D, Banker's cheque in the favor of Principal, B.N. College, Patna.
3. Cost of B.O.Q. (Nonrefundable) to be deposited through D.D. / Banker's cheque in favor of the Principal, B.N. College, Patna.
4. Eligibility criteria of the contractors participating in the tender:
 - (a) Registered contractor of Government of Bihar / C.P.W.D. / M.E.S. for appropriate category for civil & Electrical work. Working contractors of Patna University / B.N. College is only applicable for small works up to (₹s. 1,00,000) one lakh only.
 - (b) For new construction work, the agency should have past experience for same nature of work at list 50% of tender amount.
 - (c) Affidavit is compulsory for tender value more than 1 Lakh to the contractor for submission of all documents true to his knowledge. If any documents any time, any stage found fault then his candidature will be terminated & Security deposit / bill value of work done will be forfeited.

The Name of work and its serial number as per N.I.T. should be mentioned in the front of envelop, otherwise tender will not opened.

As per amendment by resolution of Rule no. 159(a) & 159 (b) of Public Works Code vide memo no. 06/1/12/2023-5676(5), Patna, dated 24/06/2015, the tender of ₹ 15 Lacks or less will not be require to publish in daily newspaper.

6. Any other information may be obtained from the office of the Principal, B.N. College, Patna during working hours in any working day.
7. The estimated cost may increase or decrees but the earnest money will remain the same.
8. The work order will be issued subject to the availability of fund.
9. The undersign reserves the right to reject any tenders or distribute the work among the tenderers without assigning any reason.
10. Quoting lowest rates in tenders will not be a claim of allotment of work.

The N.I.T. and B.O.Q. can also be downloaded from the web site <https://www.bncollegepatna.com> from intending tenders will be submitted with cost of B.O.Q. in the form of Demand draft in the favor of Principal, B.N. College, Patna. B.O.Q. submitted without cost of B.O.Q. in the form of demand draft will be summarily rejected and the last date for downloading the tender documents from the website is one day prior to the last day of receipt of tender. Accordingly, the draft towards the tender fee shall be dated one day prior to the last date of receipt of tender.

12. The sealed tender(s) should also be sent through courier / Registered / speed post. Conditional tender or tenders received after the due time and date shall not be entertained in any circumstances. B.N. College would not be responsible for any delay or loss of the tender documents, the tender(s) will be opened in the office of the undersigned by the duly constituted committee as per the above-mentioned schedule in presence of any intending supplier or his/her authorized representative who wish to be present at the designated time and place. If the fixed date turns out to be the holidays, the date of opening will be the next day.
